#### 1. Information We Collect

We collect various types of information from you when you register including:

We will use this information to communicate with you and to send to you a list of English-speaking doctors and local medical resources.
- b. Usage Information: Information about your usage of the Services, including your search queries, preferences, and location data.
- c. Device Information: Information about the device you use to access the Services, including device type, operating system, browser type, and IP address.
- d. Cookies and Similar Technologies: We may use cookies, web beacons, and other similar technologies to enhance your experience and gather information about your use of the Services.

Please note that we do not collect, store, or access your health information. Our Services provide you with a medical organization system that is stored on your device, and we have no access to this information.

2. How We Use Your Information

We use your information to:

- a. Provide the Services, including helping you locate English-speaking doctors while traveling.
- b. Improve and personalize your experience with the Services.
- c. Communicate with you about the Services, including sending you newsletters, promotions, or surveys.
- d. Maintain and improve the security and integrity of our Services.
- e. Comply with legal obligations and protect our rights, including the enforcement of our Terms of Service.
- f. When we provide feedback on usage to the group purchases of our services under whose auspices your personal subscription may be included. It will never be associated with any identifiable individual but rather lumped together in group usage data.

### 3. Disclosure of Your Information

We may disclose your personal information to:

- a. We may provide your name (and no other personal information) to doctors, healthcare providers, and other medical professionals in order to facilitate your healthcare while traveling if you are a concierge patient of MD Medical Navigators LLC, a partner of MyAbroadMDS.
- b. Government authorities, law enforcement, or regulatory agencies when required by law or in response to legal requests.
- c. In the event of a merger, acquisition, or other corporate restructuring, to the extent permitted by applicable law.

The usage data and feedback data of individual users will never be shared with any 3rd party or the group purchaser of the subscription as an identifiable individual, but only as part of a group of data on average and total usage and as data related to the health providers who were seen by clients. Personal health data will be entered and stored on a individual subscriber's own phone and will not be uploaded to our website or app.

### 7. Children's Privacy

Our Services are not intended for children under the age of 13, and we do not knowingly collect personal information from children under 13.
